# 1. Definitions

**BUTTS** – The physical barrier erected to the rear of the target area to prevent unrestricted travel of projectiles.

**Camouflage** means fabric dyed with mottled, irregular, or pixelated patterns of green, brown, tan, and black, intended to make the wearer hard to distinguish from the background.

**CEASE FIRE** – All firing is to cease immediately.

**CLEAR** – A firearm has been inspected and declared safe.

**FAMILY MEMBERSHIP** – A “family” shall be at least one or both adults and their immediate children up to the age of 18 years.

**FINANCIAL MEMBER** – Is a member who has paid the current year’s membership but shall include Life Members who are not required to pay for yearly membership.

**FIRING LINE** – The line from which live firing will occur.

**LIVE FIRE** – The actual discharge of a firearm.

**MALFUNCTION** – Failure to function properly.

**MISFIRE** – Failure to fire.

**PENSIONER** – For the purpose of membership, a pensioner is a person who has attained pension age. If a person is under pension age yet produces a medical pension card they shall be classed as a pensioner.

**QUALIFIED** – A competent person who has been approved by the Canning Club Committee or recognised authority as being able to perform an activity.

**RANGE** – All area down range of the firing line and undercover areas behind firing line

**RANGE OFFICER** – A qualified person who has completed the Canning Club Range Officers course and maintained yearly recertification who is permitted to conduct a shooting activity.

**SAFETY AREA** – A designated area for the cleaning & maintenance of a firearm. No ammunition is permitted within the safety area.

**SAFETY OFFICER** – A person designated to assist the Range Officer.

**COMMENCE FIRE** – Permission to commence firing.

**SHOW CLEAR** – Present an unloaded firearm for inspection.

**SIDE WALL** – The sides of each range to prevent the unintended travel of projectiles.

**UNLOAD** – Remove all ammunition and/or magazines from a firearm.

**VISITOR** – A person who is not a financial member of the Canning Club.

## 2. Scope

These Bylaws apply to all operations of the Canning Club (Inc.).

## 3. Authority

These Bylaws are granted authority by the Canning Club's Constitution Section 8.1 and maintained by the Committee. These Bylaws are developed with reference to the constitution.

The Bylaws shall not modify, nullify or override any portion of the Canning Club's Constitution.

## 4. Annual Review

These Bylaws shall be reviewed at least once a year by the Canning Club Committee.

## 5. Modifications to Bylaws

These Bylaws may be modified by a majority vote of the Canning Club Committee. Any financial Canning Club Member may request a modification or addition to the Bylaws. Requests shall be made to the Canning Club Committee in writing by the proposing financial member. Decisions made by the committee to amend the current Bylaws or introduce a new Bylaw, shall be published for the information of the membership as soon as practicable.

## 6. Membership (No A, B, C or H Class Firearm Licence)

Juniors (aged over 12 years and under 18 years) shall be accompanied by a Parent if aged over 12 years and under 16 years, or an adult identified by letter of permission from a parent if aged over 16 years and under 18 years at all times.

A person(s) wishing to become a member of the Canning Club shall:

- a. Visit in person the Canning Club premises at 166 Johnston Road Canning Vale.
- b. Provide photo ID.
- c. Provide a Police Clearance or a current Western Australian Firearms Licence.

- d. Collect and complete the New Member Booklet, Membership Application Form, Statutory Declaration and Statement of Understanding.
- e. Complete the required 4 training shoots (Air Pistol/Rifle/Air Rifle).
- f. Pay the Nomination Fee as outlined in these Bylaws
- g. Complete Initial Firearms Training Course – 1 full Day.
- h. Complete an introductory shoot. (Part of the Initial Firearms Training Course)
- i. Complete a minimum of 4 live fire matches on official club match days.
- j. When the above has been satisfactorily completed, membership to the Canning Club shall be reviewed by the Canning Club Committee at the next committee meeting.

If membership is granted, a new member shall:

- a. Pay pro rata balance of Membership.
- b. Commence a probation period of 6 months. (Section 24 (6) Firearms Regulations 2024)
- c. Must shoot at least 4 times in the 6-month probationary period.
- d. At the end of the probation period, the Canning Club Committee shall consider the new member for full membership.
- e. Once approved by the Canning Club Committee, the member may apply for their first Canning Club supported firearm.

## **7. Membership (A, B, C or H Class Firearm Licence)**

A person(s) holding a category A, B, C or H Firearm Licence wishing to become a member of the Canning Club shall:

- a. Visit in person the Canning Club premises at 166 Johnston Road Canning Vale.
- b. Provide photo ID.
- c. Provide a Police Clearance or a current Western Australian Firearms Licence.
- d. Collect and complete the New Member Booklet, Membership Application Form, Statutory Declaration and Statement of Understanding.

- e. Pay the Nomination Fee as outlined in these Bylaws
- f. Complete Initial Firearms Training Course – 1 full Day.
- g. Complete an introductory shoot. (Part of the Initial Firearms Training Course)
- h. The Canning Club Safety Officer may require a prospective member to complete at least 4 live fire matches on official club match days.
- i. When the above has been satisfactorily completed, membership to the Canning Club shall be reviewed by the Canning Club Committee at the next committee meeting.

If membership is granted a new member shall:

- a. Pay pro rata balance of Membership.
- b. Commence a probation period of 6 months. The club may take into account other club membership in relation to the 6 month probation period

At the end of the probation period, the Canning Club Committee shall consider the new member for full membership. Once approved by the Canning Club Committee, the member may apply for additional Canning Club supported firearms. A new member who has obtained full membership and holds a valid firearms license and has completed their probationary period may apply for club support for current firearms without the 6 month waiting period.

## **8. Membership Fees**

The committee may from time to time determine the amount of the annual Membership fees to be paid of the Association. The change in fees will come into effect as of the next fee cycle, being the 1<sup>st</sup> of July. The Committee may not increase the Membership fees more the 20% in a fee cycle.

Each Member must pay to the Treasurer, Electronic Funds Transfer or another person authorised by the Committee to accept payments, annually from July 1<sup>st</sup> to July 31<sup>st</sup> or such date as the Committee

from time to time determines, the amount of the Membership fee determined under sub-rule 3.7(1) which may be different for different classes of Membership.

A member who does not pay the prescribe membership fee by the 31<sup>st</sup> July will incur a penalty as outlined under Section 13.

Subject to sub-rule 3.7(5) a Member whose Membership fee is not paid by 31st September after Memberships fees become due, ceases on the expiry of that period to be a Member, and will be reported to the WA Police Firearms Services as no longer being a financial member (Firearms Act Section 2024 Section 375), unless the Committee decides otherwise.

Subject to sub-rule 3.7(5), a Member whose Membership fee is not paid by 1<sup>st</sup> August after Membership fees become due, will be considered ineligible for active participation in Association shooting activities.

A person exercises all the rights and obligations of a Member for the purpose of the Constitution if their Membership fee is paid on or before the relevant date fixed by or under sub-rule 3.8(2) or within 1 month thereafter, or such other time as the Committee executive allows.

## **9. Firearm Support.**

Failure to meet any requirement for eligibility will disqualify a member from being approved for club support for a firearm. The member must be a financial member of the Canning Club (Inc.). A financial Canning Club member applying for firearm support shall apply, in writing, to the Canning Club Committee. Upon approval by the Canning Club Committee for firearm support, the member shall provide details of the firearm and request a Club Support Form from the Secretary and have them duly signed off by the Canning Club President or Secretary. Under no circumstances is any person to remove incomplete copies of the Form (or facsimiles) from the club premises.

## 10. Compliance Requirements

All financial members of the Canning Club are expected to partake in club sanctioned matches.

Probationary members shall shoot at least 4 club sanctioned matches, during their 6-month probation.

To maintain Canning Club support of a firearm, a financial member shall complete a minimum number of matches per anniversary date of your firearm licence renew in accordance with the Section 32 WA Firearms Act 2024 and Section 26 (3) WA Firearms Regulations 2024, submitting a score for each match.

A financial member who is supported for a single discipline must participate in that discipline for a total of 6 shoots per anniversary date of your firearm licence renew as a minimum. A financial member who is supported for more than one discipline should participate in each discipline for a total of 4 shoots per discipline per financial year as a minimum to justify each firearm held.

Members who are unable to meet the minimum requirement must advise the Canning Club Secretary in writing prior to becoming non-compliant.

A financial member's request for leave of absence is put to the committee and approved or rejected accordingly. Leave of absence may be approved for a period not exceeding six months at a time.

## 11. Safety Inductions

All prospective Canning Club Members must demonstrate safe handgun or longarm operational procedures to the satisfaction of the Canning Club Safety Officer. All prospective members regardless of their previous experience will undertake the Canning Club Initial Firearms Training Course run by the Safety Officer and complete a minimum of 4 supervised club matches. Failure to successfully complete this training will result in your application being rejected.

Prospective Canning Club Members who do not hold a current H class (Handgun) WA Firearms license and wish to shoot a handgun shall undertake the following;

- (a) Complete a minimum of 4 air pistol shoots.
- (b) Canning Club Initial Firearms Training Course, which includes an Introductory Shoot.
- (c) Complete a minimum of 4 supervised club matches in a handgun discipline, submitting a score for each completed match.

Having successfully completed their 4 supervised club matches in a handgun discipline, a prospective Canning Club Member's name shall be submitted to the Canning Club Committee for consideration to become a New Member and commence their 6-month probation period.

Prospective Canning Club Members who do not hold a current A, B or C class (Longarm) WA Firearms license and wish to shoot a longarm shall undertake the following;

- (a) Complete the Canning Club Initial Firearms Training Course and Longarm safety induction training.
- (b) Shall complete a minimum of 4 supervised club matches in a longarm discipline, submitting a score for each completed match.

Having successfully completed their 4 supervised club matches in a longarm discipline, a prospective Canning Club Member's name shall be submitted to the Canning Club Committee for consideration to become a New Member and commence their 6-month probation period.

All members are advised to go to the Canning Club webpage and download a copy of the Canning Club (Inc.) Constitution and a copy of the Canning Club (Inc) Bylaws.

## 12. Canning Club Members

All visitors and financial Canning Club Members attending the Canning Club are required to enter the club via the front door and complete and sign the attendance book before proceeding to any other area of the club (including the ranges).

Financial members shall display their membership card at all times. Visitors shall display a Visitor Badge. Members with guests who will be partaking in shooting activities shall ensure that the visiting person completes a Visitors Form located at the front door sign in desk and hand the completed form, along with the required range fee, to the armourer, prior to moving from the club house onto the ranges.

Such visitors may not attend a range unless they are under the direct supervision of a financial Canning Club Member at all times. Visitors are limited to 3 shoots. After a visitor has completed three (3) shoots as a visitor, the visitor shall determine if they wish to apply for membership of the Canning Club.

Canning Club Members who wish to practice, shall complete the Practice Range Register with their name, membership number, date and the range they are going to practice on, **there must be a minimum of two person on the range** to ensure safety is maintained, there must also be a First Aid Qualified person present at the range during any live fire (Can be either of the people present) Section 156(4) Firearms Regulations 2024.

If a visitor is shooting with a Canning Club Member, a "V" shall be placed in the membership number column. Note: **Firearms cannot be shared unless both shooters are licensed for that firearm.** A young person aged over 12 years and under 18 years may use a parent's firearm under direct supervision

and with written permission which must be handed to the club on each occasion. Section 31

Firearms Act 2024.

The taking of photographs or videoing of club members and /or visitors without their knowledge and consent is strictly forbidden.

Members are advised that for Safety and Security reasons there are cameras on all ranges, within and around the club premises and in the parking areas.

## 13. Membership Fees

### Fees

Fees are paid annually and fall due 1<sup>st</sup> July and before the 31<sup>st</sup> July:

The Canning Club fees are as follows **and are non-refundable**:

## 15. Canning Club Committee Members

The club committee members shall be made up as follows and the committee numbers shall be limited to a minimum of 14 and a maximum of 25 persons in accordance with Part 5 Division 2 of the Canning Club Constitution.

- a. Vice Secretary
- b. Safety Officer
- c. Armourer
- d. Scorer
- e. Canteen Manager
- f. All Discipline Captains (making up a maximum total of 14 persons).
  - a. Mandar
  - b. Field Pistol
  - c. Air Pistol
  - d. Black Powder

- e. Single Action
- f. Revolver
- g. Centre Fire
- h. Steel Challenge
- i. Action Match
- j. Practical Shooting
- k. Rifle (includes Bench Rest, Hunter Class, Fly, etc.)
- l. Outdoor Air Rifle
- m. Air Rifle
- n. Lever Action

All nomination for committee positions must be in writing on the approved form and forwarded to the Canning Club Secretary, 15 days before the Annual General Meeting (AGM).

Nominees for club committee positions shall have their name and photograph posted on the club house notice boards 7 days prior to the AGM.

Any Canning Club member may nominate for a committee position provided they meet the condition of Clause 5.7 in the Constitution and are not, nor likely to become a member of another similar Association's committee.

If a person holds, or in the future may hold a position on another similar Association's committee then that person becomes ineligible to sit on the Canning Club committee.

## **16. Life Membership**

Any financial member of the Canning Club may nominate another financial member of the Canning Club for life membership.

Nominations shall be addressed to the Canning Club Committee in writing, detailing the merits of the nomination.

The Canning Club Committee shall review the nomination and make a recommendation based on the stated merits of the nomination and then the nomination shall be presented at the next AGM for membership approval.

## **17. Bringing the Canning Club into Disrepute**

Any financial Canning Club Member who brings the Canning Club into disrepute by their actions may have their membership suspended or withdrawn by the Canning Club Committee.

Only Canning Club Members that have been appointed by either the Canning Club President or the Canning Club Committee may represent in an official capacity, the Canning Club at any external

association's meeting. The representative must report back to both the Canning Club President and the Committee, any deliberations and resolutions that they have participated in while representing the Canning Club.

The representative shall also take direction from the Canning Club President and/or the Committee with regards to any actions arising from their attendance at the meeting of other external associations.

If the club representative does not follow the instructions or directions given to them by the President or Committee, this will be regarded as bringing the club into disrepute and their membership shall be subject to disciplinary action.

Any member under suspension or expulsion, who subsequently appeals the suspension or expulsion, shall not be permitted to attend the Canning Club's premises until the appeal process is completed. Expelled members may not attend the Canning Club premises in either a social or competitive capacity.

Any person, not being a member, who is considered unsuitable or disruptive to the standards of the Canning Club, may be served a notice advising that they may not attend the Canning Club premises. No financial Canning Club Member shall make a statement to any media that inappropriately references the Canning Club.

## **18. Keys**

Keys to Canning Club are a privilege and may be issued to financial Canning Club Members who have been a financial member for 24 months and are deemed eligible by the Canning Club Committee. A refundable key deposit of \$50.00 will be collected from each financial Canning Club Member who receives a key.

## **19. Change of Address**

Any change to contact information (address/phone number etc.) must be communicated to the Canning Club Secretary in writing, within 14 days.

## **20. Driving**

The road into the Canning Club is a Gazetted Road and your speed is restricted to 60 KPH. Due to the prevalence of motorbikes, 4WD vehicles, wildlife and to maintain the condition of the road, the

Canning Club recommends speeds below 50 KPH. Upon entering the Club grounds the speed limit is restricted to 20KPH.

## **21. Alcohol**

No alcohol is to be consumed on the premises by Canning Club Members or visitors prior to undertaking any firearms activities (including those not intending to shoot) or if there are any firearms present in the vicinity of where those members are drinking. The Canning Club does not allow alcohol on the ranges at any time.

## **22. Smoking**

Smoking, including vaping is prohibited in areas that are undercover unless designated as a “Smoking Area.”

## **23. Busy Bees**

Canning Club Members who attend the club on nominated Busy Bees will receive a discount limit of \$50 per Busy Bee to a maximum of \$100 per membership Year, to the following year’s annual membership fees.

Junior members are exempt from this rule. Family memberships will be counted as one membership.

Pensioner members who attend the club on nominated Busy Bees will receive a discount of \$50 per Busy Bee attended for a minimum of 3 hours to a maximum of \$100 per membership year.

## **24. Social Shoots**

The Canning Club may host social shoots as a fundraising activity.

Any social shoot must be approved by the Canning Club Committee and range fees set \$200.00.

All social shoots shall be conducted by a qualified Range Officer and Safety Officers. A First Aid Trained person must be present at the range whilst the social shooting activity is taking place. Upon completion of the social shoot, the reporting document and all monies collected shall be forwarded to the Canning Club Treasurer as soon as practicable.

## 25. Range Procedures

Canning Club shooting matches shall commence no later than the time designated on the Canning Club Calendar or as determined by the Range Officer (e.g. allowing for the setting up of the range). The Range Officer (RO) may start a match at an earlier time at their discretion (e.g. a full detail ready).

All shooting must cease at or before 9:00 pm.

RO's shall use the Canning Club's standard range commands and complete a RO Checklist. The RO who is responsible for running the match shall wear a yellow Range Officer's vest. Safety Officers shall wear an orange vest. All prospective Canning Club Members shooting their 4 supervised shooting matches shall wear a blue vest, visitors from other clubs shall wear a green vest. The wearing of coloured vests is not mandatory for the single action discipline.

The Range officer is not permitted to participate in any shooting activity whilst fulfilling the duties of a Range Officer (Firearms Act 2024, requires authorised person to have immediate supervision of range activities)

Any member or visitor who is removed from a range for a safety breach or disqualifying incident is not permitted to shoot on any other range for the remainder of the day, this is to ensure that safety is maintained at the highest standard and ensure that all participants are in the right frame of mind to undertake live fire activities.

No camouflage clothing is permitted to be worn at the Canning Club for any shooting activity. High visibility clothing is not to be worn by any member undertaking a shooting activity, this is to ensure that there is no confusion as to who is performing the range roles.

## 26. Safety Areas

Firearms may be handled, cleaned or examined in designated safety areas. No live Ammunition is permitted in a safety area at any time.

## 27. Holsters

Financial Canning Club Members shall not use a holster without having successfully completed the appropriate holster qualification course for that discipline.

All holsters shall comply with the requirements of the relevant discipline rulebook. If the relevant discipline rulebook provides no standard, the match discipline standard shall be applied.

No rearward facing or leg holsters shall be worn. Where the discipline does not require a holster (e.g. Mandar), holsters shall not be worn.

Practical Pistol, Single Action, Action Match and Steel Challenge are approved holster disciplines.

Holsters worn during practice shoots must have a minimum of two (2) members and/or a member within sighting/visible distance.

Holstered Single Action revolvers that are being used during a single action match are exempted from a holster requirement of having the trigger guard covered.

Any financial Canning Club Member who uses a holster on the Canning Club premises must be prepared to produce documentation indicating their successful completion of an appropriate holster qualification course.

Holstered firearms shall not be worn in the club house.

## **28. Club Championship Matches**

All financial Canning Club Members who have completed their minimum Canning Club matches attendance shall be eligible to compete in club championship matches.

## **29. Range Orders**

All financial Canning Club Members and competent persons from other clubs participating in a shooting match shall comply with these orders to ensure maximum safety and efficiency during range use.

You must adhere to these Safety Orders at all times.

- a. Treat all firearms as loaded.
- b. Keep the muzzle pointed down range at all times.
- c. Keep your finger off the trigger until engaging a target (on target on trigger, off target off trigger). Off trigger means outside of the trigger guard in the Canning Club.
- d. Identify your own target.
- e. Do not move forward of the firing line unless directed by the Range Officer and only after all firearms have been unloaded, shown clear and secured.
- f. Do not bend down to pick up anything you have dropped, raise your support hand and request assistance from a Safety Officer.

- g. Eye and Ear protection and enclosed footwear shall be worn for all handgun shoots. Rifle shooters (including Air Rifle) will be subject to the Range Officers discretion in relation to the wearing of ear protection and eye protection if shooting with closed bolt or lever action rifles, with or without telescopic sights.
- h. No camouflage or hi viz clothing is permitted to be worn on the range by participants.
- i. No Jacketed or Plated Centre Fire Ammunition is to be used on any range, if in doubt present to the Range Officer for inspection
- j. Magazines/Speed Loaders/Moon Clips may be charged before attending the firing line but shall not be loaded into a firearm.
- k. A person shall not load a firearm unless directed by the Range Officer. All firearms are to remain unloaded until you are on the firing line and have been given the command to load and make ready.
- l. Directions and instructions given by the Range Officer shall be obeyed at all times. Failure by any person to carry out instructions or directions will render that person or persons liable to removal from the range.
- m. Safety breaches shall be reported immediately to the Range Officer who shall complete an Incident form.
- n. Safety is everybody's responsibility. Anybody, either on the line or observing can call the command STOP, STOP, STOP or CEASE FIRE, at which time all shooters shall stop and await further instructions from the Range Officer.
- o. Any person who breaches any of the above safety rules will be given one warning, any further breaches will result in that member being removed from the range for the remainder of the day, a record will be kept and three such removals within a 12 months period will result in the member having to undertake the Initial Firearm Training again.
- p. Any hired firearm that develops a fault whilst on the line, must be reported to the armourer who will keep a record of the firearm, the fault and the action taken to rectify the fault.

### **30. Additional Range Requirements**

1. All red flags to be displayed prior to any live firing.
2. No camouflage clothing is to be worn at Canning Club at any time.
3. Persons with a firearm shall ensure that the firearm and any ammunition is secure at all times.
4. Firearms shall not leave the Firing Line in a loaded condition.
5. Whilst participating in live firing and the firearm or ammunition is found to be malfunctioning or faulty, the shooter is to attempt to clear the malfunction and continue if

- safe, cease the activity and raise the support hand and indicate that assistance is required and wait for directions from the Range Officer.
6. During live firing where a pause or rest is taken or cease fire is ordered, all shooters shall remain at the firing line and hold their firearm pointed downrange in the standby position;
    - a. Pistol – (45 degrees downwards) and await further instructions.
    - b. Rifle – Placed on the bench with the barrel pointed down range
    - c. Air Rifle – Placed on the bench with the barrel pointed down range
  7. Spectators shall remain at the rear of the firing line or as directed by the Range Officer and are not to distract shooters.
  8. All mobile phones to be turned off or silenced whilst a match is in progress.
  9. Steel targets are to be set no less than 10M from the firing line and no closer than 5M from the butts, unless it is a Canning Club approved discipline match.
  10. Members are not to visit the range alone out of hours for shooting activities.
  11. All club rules apply to members visiting the club out of hours.
  12. A person trained in first aid must be present at the range regardless of how many people are shooting or when.
  13. On occasion, external providers make use of the range and the clubhouse, club members must not interfere with their operations.
  14. The Range Officer may suspend from shooting for the rest of the day anyone who, in their opinion, breaches any one of the Range Orders or Safety Instructions. The Canning Club Committee may consider the incident and appropriate action may be taken against the offender (which can include warning through to expulsion from the club).
  15. Any shooter who discharges a firearm before or after the course of fire has commenced or been completed will be told to un-load, show clear, bag their firearm and leave the line. (NO DISCUSSION will be entered into with or by the range officer).
  16. Any member who is found practice shooting on a range and has not placed their name on the 'white board' outside the club house adjacent to range 1, will be told to bag their gun and told to leave the range for the day.
  17. When practicing on the Ranges members must communicate their intentions to others who are also using the same range.
  18. There must be a minimum of 2 people present when practicing on a range. There must also be a first aid trained person present at the range (Can be one of the two people at the range) (Section 156(4) Firearms Regulations 2024).
